The **Hong Kong Corporate Governance and ESG Excellence Awards 2024** invites nominations from Hong Kong listed companies with outstanding commitment to shareholder rights, compliance, integrity, fairness, responsibility, accountability, transparency, board independence & leadership, and ESG.

## Now Open for **Nomination**

### Objectives

The **Hong Kong Corporate Governance and ESG Excellence Awards**, previously known as The Hong Kong Corporate Governance Excellence Awards, was inaugurated in 2007. The Awards programme adopted its present name in 2021 to reflect the increasing importance of ESG (Environmental, Social and Governance) to listed issuers and the investing public.

The Awards are conferred annually by the Chamber of Hong Kong Listed Companies (CHKLC) and the Centre for Corporate Governance and Financial Policy, Hong Kong Baptist University (CCGFP) and are designed to encourage improvement in corporate governance (CG) and ESG of listed companies in Hong Kong.

The Awards provide recognition and prestige for listed companies in achieving outstanding commitment to shareholder rights, compliance, integrity, fairness, responsibility, accountability, transparency, board independence & leadership, and ESG.

The Awards programme aims to:

- ▶ Foster the highest standards (i.e. beyond regulatory requirements) in corporate governance, business ethics, board leadership and ESG in Hong Kong.
- ▶ Recognize excellence of corporate governance and ESG of listed companies that adopt exemplary standards.
- ▶ Raise the level of corporate governance and ESG in Hong Kong by showing best practices and accomplishments of listed companies.
- ▶ Promote a strong culture of good corporate governance and ESG by recognizing companies that have made significant improvements or important contributions to these areas.

### Award Categories

Nominations are invited from companies listed on the Stock Exchange of Hong Kong that demonstrate excellence in two Award Categories :

#### I. Excellence in Corporate Governance

#### II. Excellence in ESG

Under the respective award category, candidate companies will enter for sub-groups as below :

- 1. Hang Seng Index Constituent Companies**
- 2. Hang Seng Composite Index Constituent Companies**
- 3. Hang Seng China (Hong Kong-listed) 100 Index Constituent Companies**
- 4. Weighted Voting Rights and Pre-profit Biotech companies**

(Listed under HKEX Main Board Listing Rule 8A and Chapter 18A, respectively)

#### 5. Others & GEM Companies

#### 6. Newly-listed Companies

(companies listed within 3 years before the year of award nomination and having published at least two annual reports; companies listed for no more than three years on the Stock Exchange of Hong Kong shall enter for the Newly-listed Companies category.)

Note: Each company can be nominated for only one sub-group

Companies can choose to enter for one of the sub-groups 1-6 for either the "Award of Excellence in Corporate Governance" or "Award of Excellence in ESG", or Both. Assessment will be done on the candidate companies' performance and achievements in Corporate Governance and ESG, respectively, in accordance with their nomination.

**Special prizes or honourable mentions** may also be awarded to honour those companies that have demonstrated exceptional commitment and achievement in a particular area of corporate governance or ESG as stated in the "Criteria and Selection Process" section of the Awards website "[cgesgawards.chkcl.org](http://cgesgawards.chkcl.org)".



## Judging Criteria

Nominated companies will be considered for their commitment and achievement in prescribed criteria under applicable Categories, as spelled out in the Awards website "[cgesgawards.chkclc.org](http://cgesgawards.chkclc.org)". Special attention will be given to candidate companies' innovations and significant improvements in corporate governance or ESG; efforts made to internalize and pursue the highest principles over-and-beyond compliance; and ability to show positive business impact of the corporate governance or ESG spirit and practices.

## Selection Process

CHKLC and CCGFP will provide oversight of the Awards policies, selection process and criteria. This will involve an Expert Review Group (ERG) to conduct an independent review of the submissions, and an Award Judging Panel (AJP) to interview the short listed companies.

## 目標

「香港公司管治與環境、社會及管治卓越獎」(前稱「香港公司管治卓越獎」)，自二零零七年起舉辦，於2021年改為現名，以反映環境、社會及管治(ESG)對上市企業和投資大眾的日益重要性。

獎項計劃由香港上市公司商會與香港浸會大學公司管治與金融政策研究中心每年聯合頒授一次，旨在鼓勵香港上市公司加強公司及 ESG 管治。

該獎項對在維護股東權利、合規、誠信、公平、責任、問責、透明度、董事會獨立性和領導力及推行 ESG 等方面作出承諾並取得突出成就的上市公司，予以肯定及嘉獎。

獎項計劃旨在：

- ▶ 提倡香港公司管治、商業道德，董事會領導能力及ESG 方面的最高標準(即超出法定要求)。
- ▶ 對在公司管治及 ESG 方面採納高標準而又取得卓越成就的上市公司加以表揚。
- ▶ 展示上市公司的最佳實務及成就，提高香港公司管治及 ESG 水平。
- ▶ 嘉許在公司管治及 ESG 方面有重大改進或作出重大貢獻的公司，進一步穩固香港的公司管治和 ESG 文化。

## 獎項類別

「香港公司管治與環境、社會及管治卓越獎」歡迎於香港聯合交易所上市、並在下列範疇取得卓越成就的公司，提名參加角逐兩大類別獎項：

### I. 公司管治卓越獎

### II. 環境、社會及管治卓越獎

在此兩大類別下，企業需選擇參加下列一個組別參與角逐：

1. 恒生指數成份股公司
2. 恒生綜合指數成份股公司
3. 恒生中國(香港上市)100指數成份股公司
4. 不同投票權架構公司及未有收益的生物科技公司  
(分別根據香港交易所《主板上市規則》第八A章及第十八A章上市)
5. 其他及GEM公司
6. 新上市公司  
(於參選獎項年份前三年內上市並刊發最少兩份年報，凡於聯交所上市不足三年之公司應參選新上市公司組別。)

註：每家公司只能在一個組別提名角逐獎項

每家參選公司可選擇於「公司管治卓越獎」類別或「環境、社會及管治卓越獎」類別下(一)至(六)其中一個組別參與角逐，亦可以同時參與角逐兩個類別。大會將依據公司的選擇分別就其於「公司管治」和「環境、社會及管治」之表現和成就作出評審。

為表彰在個別公司管治層面(載於獎項網頁cgesgawards.chklc.org「評審與遴選」部份)有特別承擔及顯著成就之公司，大會評審可因應情況頒發**特別獎**或**特別嘉許**。

### 香港上市公司商會
